

Safety Netting Installers CSCS Card Categories

Immediate NVQ Registration

- **Trainee Card – 3 year life (Not Renewable)**
- **Experienced Worker – 1 year life (Not Renewable)**

Lack of NVQ Assessors restricts the availability of these routes.

Deferred NVQ Registration

- **FASET Trainee Card – 18 month life (Not Renewable)**
- **FASET 1 Year Experienced Worker Card – 1 year life (Not Renewable)**

The 'Deferred' cards allow the applicant to obtain a CSCS card without registering on the NVQ. They will however require the holder to register for and progress their NVQ before the card expires, or they risk being uncarded.

Permanent Cards

- **Experienced Worker (Grandfather Rights) card – New applications no longer accepted.**

5 year life – Fully renewable subject to FASET Site Assessment and H&S Test

- **Full Skilled Card (for holders of NVQ Level 2)**

5 year life – Fully renewable subject to FASET Site Assessment and H&S Test

Or if Training Certificate Has Expired

FASET Experienced Worker – Undertake FASET Site Assessment (GSA-1) 100% Pass Mark

If you fail to get 100% on GSA-1 Theory you must undertake FASET Inspectors Course with a 100% Pass Mark to gain a **FASET Experienced Worker Card**
If you fail to pass your GSA-1 practical, or fail to gain 100% on FASET Inspectors Course, you must retake the full FASET Training Course and register for a **FASET Trainee Card**

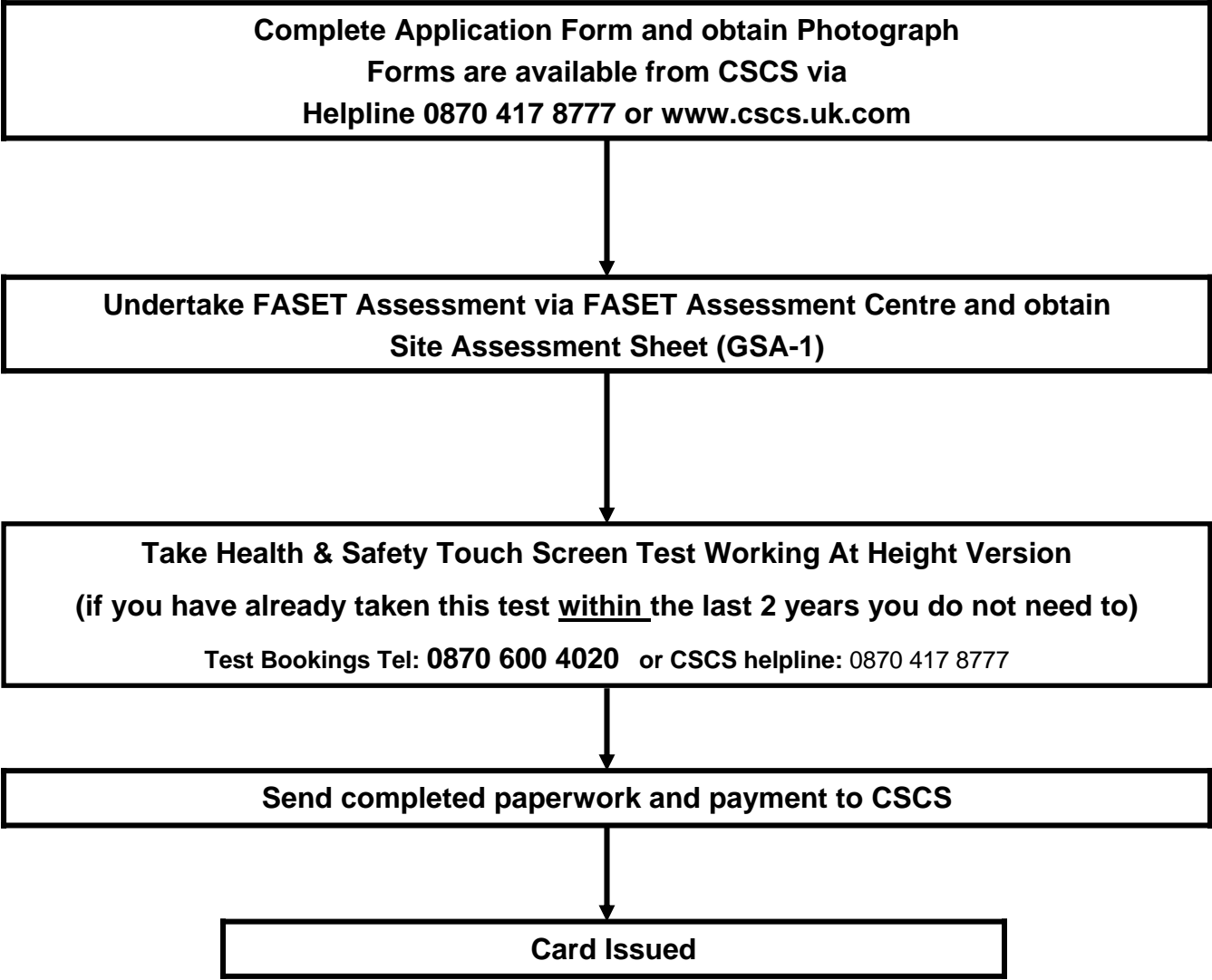
